HEDIS Recommended Minimum Documentation to Copy . Directions: Evidence is required to support both compliant and non-compliant findings. Refer to appropriate measure and copy the pieces of evidence listed. Confirm with the office staff that the entire medical record is present. Include member name and date of birth on each page if possible.

Transitional Care Management Services

Documentation in the medical record must include the DOS of the test and the test result in order to ensure compliance. In some cases, CPT Category II codes must be submitted by the care provider type that meets the intent of a HEDIS® measure. For example, medication review must be completed by a prescribing care provider or clinical pharmacist to

Conditions can be coded when documentation states condition is being monitored and treated by a specialist "Patient on Coumadin for atrial fibrillation; followed by Dr. Hill" Co-existing conditions can be coded when documentation states that the condition affects the care, treatment, or management of the patient.
