## **Civil Documents - Travel**

Also, bring the original documents (or certified copies) plus a photocopy to your visa interview at the U.S. Embassy or Consulate. Gather and send copies of any of these supporting documents that apply to your situation: Adoption Documentation

## **Uploading supporting documentation to CEAC**

You will have to scan and upload them to the NVC portal in advance and carry the original documents or certified copies to the consulate at the time of your interview. All documents that pertain to your petition are required, even if they were previously submitted to the USCIS with your petition.

Uploading new civil documents or supporting evidence To upload a required document in the CEAC, click on the arrow next to the document name. Then choose "attach document" to move to the upload screen. To upload a document follow the detailed steps on the upload screen.

Once the NVC receives your affidavit of support form (s) and supporting documents, they will review them for technical completeness and correctness. If any of the form (s) are technically not correct or complete, the NVC will ask the petitioning sponsor to correct and complete the applicable form (s) a second time.

## **Nvc Supporting Documents**

After you collect the financial evidence and supporting documents, you must submit all required items in ONE package to NVC. Your case may be significantly delayed if you don't submit all of your documents at the same time. IMPORTANT: Do not send your original passport or original civil documents such as birth, and marriage certificates. Instead, submit a photocopy of these documents to NVC.
