Supports, Modifications, and Accommodations for Students ...
When a student with dyslexia is eligible for accommodations in the classroom through an IEP or Section 504, those accommodations need to be individualized to fit the unique needs of the student. Accommodations are discussed at the annual IEP meeting, during which the educational team determines the accommodations that will help support student success.

Testing Accommodation for Section 504 and IDEA Students
Refer to this checklist of common modifications and accommodations to get to know options for struggling students. ... Have a “designated reader”—someone who reads test questions aloud to students. Hear instructions spoken aloud. Record a lesson, instead of taking notes. Get class notes from another student.

For many students with disabilities—and for many without—the key to success in the classroom lies in having appropriate adaptations, accommodations, and modifications made to the instruction and other classroom activities. Some adaptations are as simple as moving a distractible student to the front of the class or away from the pencil sharpener or the window.

ADA Requirements: Testing Accommodations
To support the participation of children with disabilities in such large-scale testing, accommodations or modifications may be necessary in how the test is administered or how a given child takes the test.

Testing Accommodations For Students With

If a candidate shows the receipt of testing accommodations in his or her most recent IEP or Section 504 Plan, and certifies his or her current need for the testing accommodations due to disability, then a testing entity should generally grant those same testing accommodations for the current standardized exam or high-stakes test without requesting further documentation from the candidate.

Testing Accommodations - web

Student will be placed in a testing room with no more than nine (9) other students testing with accommodations. Any student approved for testing accommodations is automatically placed in a small group testing environment, not to exceed ten (10) students, regardless of approval for the small group setting accommodation. Accommodations do not change the content of instruction, give students an unfair advantage, or change the skills or knowledge that a test measures. Accommodations, provided for both testing and instruction, change the way students access information and demonstrate their knowledge, skills, and abilities; they do not change academic standards or expectations.
